## Message from the Executive Director: The Benefits of Risky Outdoor Play for Children

RECENTLY I ATTENDED the Lawson Foundation Outdoor Play and Early Learning Policy Research Symposium, which brought together outdoor play and early learning researchers and practitioners from Canada, Finland, Sweden, Netherlands, Scotland, Ireland and the United States. CASSA was invited so that the voice of school system leaders could be included, given that early learners arrive at our doorsteps every morning.

The Lawson Foundation provided participants with a Position Statement on Active Outdoor Play. "Access to active play in nature and outdoors—with its risks—is essential for healthy child development. We recommend increasing children's opportunities for self-directed play outdoors in all settings—at home, at school, in child care, the community and nature."

Not only were the benefits of play being advanced but the notion of "risky outdoor play" was an important theme for the symposium. I heard from researchers and early childhood educators about the physical and mental health benefits of outdoor play. Outdoor Play Canada states that "risky play is a thrilling and exciting form of play that involves the possibility of physical injury and can include play with great heights, play with high speed, play with dangerous tools, play with dangerous objects, play near dangerous elements, rough-and-tumble play and play where children can 'dis-

appear' or get lost. Risky play provides opportunities for challenge, testing limits, exploring boundaries and learning about injury risk."

While the notion of encouraging children to engage in dangerous play may be difficult to immediately embrace, the research is clear on the many physical and mental health benefits that result when children play outdoors.

seen as having all the answers, and they do not fare well if they make that claim. Today leaders need to have an understanding of power, collaboration, inclusiveness, sustainability, serving, regulations, teaching and learning, and this list is by no means exhaustive. # World of 7 Billion Video Contest: Prizes for Students and Curriculum Resources for Teachers

BACK BY POPULAR demand, Population Education's World of 7 Billion student video contest helps teachers bring technology and creativity into middle and high school classes. The contest challenges students in grades 6 to 12 worldwide to create a short video connecting world population growth to one of three global challenges:

# World of Billion

#### **Preserving Biodiversity**

Habitat destruction/fragmentation, ecosystem diversity, coral reefs, deforestation, pollinators, extinction, invasive species

#### Sustainable Resource Use

Energy, fossil fuel use, single-use products, diet, overfishing, global inequities in consumption

#### **Protecting Human Rights**

Poverty, barriers to education, women and girls, forced migration, environmental/social justice, economic security

In the fall of 2011, the world's population surpassed seven billion. It's important to understand how this milestone was reached, analyze the impact of the choices we make, and realize that our decisions can and will impact the future.

This student video contest makes a compelling class project by using current issues that affect everyone around the world. All video submissions must address how population growth affects the chosen challenge topic and include at least one idea for a sustainable solution.

Public system leaders from across Canada may wish to alert the teachers in their school districts about the opportunities offered by this worldwide contest.

Students can win cash prizes, including a \$1,000 first-place prize for high school students and \$500 first-place prize for middle school students.

Participating teachers will receive free curriculum resources. Downloadable lesson plans are available now on the contest website.

### Your Leaders & Learners E-newsletter: Looking Back and Looking Forward

IN DECEMBER 2004, the first issue of *Leaders & Learners*, CASSA's national electronic newsletter, was published and shared online.

This communication initiative, developed by former Executive Director **Frank Kelly**, former Professional Development Director **Ed Wittchen** and current Editor **Tara Lee Wittchen**, was created to expand and evolve the scope of the old *CASA CLIPS* newsletter. The new newsletter featured an updated title and design template, and had a specific mandate:

- to communicate regularly with all CASSA members in an appropriate professional newsletter format
  - to inform members about executive activities
- to inform members about promising practices and success stories from affiliate associations and member school boards
  - to profile CASSA leaders from across Canada
- to encourage participation of all members in CASSA activities, including the annual conference
  - to build leadership capacity on a national level
  - to inform education partners about CASSA
- to promote CASSA as the national voice for public education in Canada

Over the years, that mandate grew to include promotion and coverage of the annual CASSA conference, updates from regional affiliates, and reports on AASA and other international events attended by CASSA members. *Leaders & Learners* also began to include profiles on CASSA conference sponsors, a step intended to strengthen those important relationships.

As the newsletter continued to evolve, so too did CASSA. What was known in 2004 as the Canadian Association of School Administrators (CASA) is now called the Canadian Association of School System Administrators (CASSA). Its French language title was also updated: Association Canadienne des Gestionnaires de Commissions Scolaires (ACGCS). Its constitution, bylaws, executive, board of directors, affiliate members and website have all changed over the years as well, with those changes regularly recorded in these pages.

CASSA members and other education professionals from across North America helped contribute to features covering topics such as off-campus schools, Indigenous education and achievement, rural and urban school boards, women in leadership, mentorship, STEM and STEAM education, early childhood development, living school initiatives, Black History Month, effective

communication, democracy, recruitment strategies, mental health, northern district issues, human rights, literacy, inclusion strategies, technology and more.

Over the last 14 years, this newsletter has included features on innovative and inspiring leaders such as Dr. Paula Barrett, Dr. Edwina Wetzel, David Bouchard, Roger Garriock, Budge Wilson, Frank Turner, Dr. Michael Fullan, Natalie Panek, Dr. Stan Kutcher, Ashleigh McIvor, Dr. John Malloy, Leora Schaefer and the late Dr. Fraser Mustard, many of whom were keynote address speakers at CASSA conferences.

The annual EXL Awards were reported on in these pages, including biographies of each of the nominees. Each new president was profiled as they started their term, and system leaders from across Canada were featured in the ongoing Faces in the Crowd series. Notable milestones such as the retirement or passing of longtime members were also recorded here.

CASSA presidents Ruth Mattingley, Bob Mills, Jim Gibbons, Jim Grieve, Carol Gray, Lee Ann Forsyth-Sells, Roger Nippard, Cindy Finn and Anne O'Brien contributed messages for each issue. Executive directors Frank Kelly and Ken Bain also provided updates in their messages. Many members, including Ed Wittchen, Cindy Finn, Carol Gray, Simone Rose-Oliver, Barry Wowk and more, submitted photographs from conferences and other CASSA gatherings.

In 2009, Matrix Group Publishing Inc. began producing a twice-yearly print magazine for CASSA, also called *Leaders & Learners*. In 2019, Matrix will take over publishing this e-newsletter. The company has a solid track record of creating, editing and publishing excellent communication products for a number of professional associations across Canada. There is much to look forward to in the continuing evolution of the *Leaders & Learners* newsletter and CASSA.

# CASSA Awards: Recognizing Outstanding Leadership

DO YOU WORK with an outstanding CASSA colleague? Do you know a Canadian school system leader who deserves to be recognized for their service? Consider putting their name forward for the Honourary Life Membership, the Distinguished Service Award or the annual Xerox EXL Award. The awards are presented each year at the CASSA conference in July.

The Honourary Life Membership recognizes excellence in education at the national level. It is normally meant to honour individuals who have contributed significantly to CASSA. Significant contributions at the provincial affiliate level will be considered only in light of their relevance to CASSA and its national mandate.

The Distinguished Service Award is intended to recognize any present or recent CASSA member who has demonstrated outstanding ability and leadership.

The CASSA executive will consider the suitability of candidates for these two awards based on responses to the items in the nomination forms.

The EXL Award recognizes the outstanding leadership of superintendents and directors of education from across Canada. CASSA members who have exhibited exemplary leadership ability and who have enhanced school administration are eligible to receive this award.

What kind of qualities should an EXL Award nominee have? They will have brought honour to themselves, their colleagues and their profession. They have given exemplary service to their provincial, territorial or national professional association. They have made significant contributions to the field of education through their service, writings or other activities. They serve as role models and teachers to others and have at least five years of membership in CASSA.

The recipient of the EXL Award is invited to attend the annual AASA conference in the United States as the Canadian Superintendent of the Year. The recipient is also profiled in CASSA's *Leaders & Learners* newsletter.

Nomination forms are available on the CASSA website. Nominations for the 2019 award should be sent to your regional affiliate or to CASSA's Executive Director Ken Bain. They will be accepted until May 16.
