# **Our Shared Priorities:** The Canadian Educational Landscape

ducators across the nation are committed to improving student achievement, helping all students to succeed and closing the achievement gap. We share the same vision of continuous improvement in student learning, and we also share many of the same challenges. At CASA, we believe that by bringing together educational leaders to share expertise, experience and ideas, we will raise education to new heights for the benefit of our students.

Delegates at the 2004 CASA Annual Conference had the privilege of hearing from some of Canada's outstanding leaders in education. These senior educational administrators came together as a

panel to discuss our common issues and challenges, and to present possible solutions. We heard from John Carlyle, former deputy minister (Manitoba) and current superintendent for River East Transcona School Division; Maria David-Evans. former deputy minister (Alberta); Denis Vaillancourt, assistant deputy minister (Ontario); Dennis Cochrane, deputy minister (Nova Scotia); and Chris Gonnet, director of learning (Yukon).

Each of the panel members gave an overview of the current priorities and challenges facing their provincial or territorial jurisdictions. The most striking aspect of the discussion was not the many differences that exist in education across the country, but rather how many priorities and challenges we actually share. Some common themes emerging from this panel discussion included:

- increased public attention to ensure high quality results
- accountability for student success
- improved student outcomes
- closing the achievement gap—success for all students
- focusing on literacy and numeracy
- meeting learning needs of First Nations students
- public demand for character education
- the importance of engaging parents in their children's education
- meeting the growing population of special needs students
- governance
- declining enrolment—scarce resources
- aging buildings
- strengthening school-to-work transitions
- safe schools
- developing professional learning communities

These educational leaders instilled pride in all of us as they highlighted the many innovative strategies and programs being carried out across Canada. Exciting things are happening in each province and territory imagine what we will accomplish if we continue to learn from one another and share our successes.

### **Conference Panelists Discuss Provincial, National And International Perspectives On Education**

highlight of the 2004 Annual Conference was a panel chaired by Frank Kelly outlining issues in carrying out provincial education policies. Don Kussmaul, president of the American Association of School Administrators, joined six Canadian affiliate representatives to talk about provincial, national and international perspectives on education. **Jim Gibbons** reported that the **Alberta** government has endorsed 86 recommendations from the 2003 provincial learning report. These include 30 minutes of physical education in grades 1–9; class caps of 17 in K–3, 23 in grades 4–6, 25 in grades 7–9, and 27 in grades 10–12. Plans are underway for a provincial fibre optic installation.

**Jan Schubert** stated that provincial testing in

**Manitoba** is held only in grade 4. Superintendents are discussing governance. Schools there have diverse populations and there is an emphasis on offering programs for Aboriginal students.

Patricia Manson commented on the effects of the new Ontario government and the challenges of developing new forms of consultation. She (Continued on page 7)





*(Continued from page 3)* identified issues including special education funding, transportation, the elementary class cap of 20, and the problems of collective bargaining across the province.

**Carol Gray** said a deputy minister was appointed for the English system in **Quebec**, which represents 10 percent of students. She described accommodation regulations, including the "last school in the village" law. She also commented on integration design in both Quebec systems. Alex Dingwall described recent governance changes in New Brunswick. The system is fully government funded; the current model could be described as true educational governance. Board meetings focus on education, not operations. Research-based initiatives are underway in areas such as male literacy. The province wants to revitalize its extensive technology superstructures.

John Darroch, speaking as past president, shared CASA's perspectives and directions. He emphasized that the association should direct its efforts toward:

- advocacy for public education
- national leadership development
- ethical positions for policy direction
- programs for our diverse population
- long-term systemic changes
- dispelling the myths surrounding public education
- establishing the purposes of education
- distinguishing process and content
- reinventing appropriate rights and responsibilities

Don Kussmaul brought the perspective of American superintendents. He commented on problems created by the "No Child Left Behind" legislation and the AASA position that it labels children. He asked CASA to consider the learning styles of of new leaders who are part of Generation X, pointing out the different ways they process information. He also advised monitoring carefully trends affecting education leadership.
