IT IS WITH great pleasure that *Leaders & Learners* announces the 2018 Canadian Superintendent of the Year is **David Keohane**. David is the recipient of this year's Xerox Excellence in Educational Leadership Award, also known as the EXL Award.

The EXL Award is presented at each national conference to the CASSA member who has exhibited exemplary leadership ability and who has enhanced the profession of school administration throughout their career.

The EXL award has been presented since 2002. Recipients also receive honourary life memberships to CASSA.

2018 EXL Award: Exceptional Leadership in Canadian Education

The Canadian Superintendent of the Year is also recognized each year at the American Association of School Administrators (AASA) conference, where the American Superintendent of the Year is selected. The 2019 AASA conference is scheduled to take place in Los Angeles, California, from February 14 to 16. Each EXL national award recipient is invited to attend this important leadership gathering.

David has been Superintendent for Greater St. Albert Catholic Schools since 2009 and has been a CASS (College of Alberta School Superintendents) member since 2001. Among his professional achievements and accolades, David was commended in 2016 by ThoughtExchange for his work in reducing the stigmas around mental health and bullying by facilitating focus groups and online exchanges for more than 3,000 participants.

His school district, Greater St. Albert Catholic Schools, was recently recognized with a Gallup Great Workplace Award and was ranked in the top one per cent of international organizations for employee engagement.

School board Chair **Serena Shaw** applauded David on receiving this honour and noted "his leadership is exemplary; David is a model and witness to our vision in all that he does to inspire excellence in learning through faith, relationships and engagement. He is a leader who places high value on engaging our staff and students that also

extends into the community to ensure their voice around questions that are important to the district reflect their interests."

Copyright and Fair Dealing Reference Materials

For Principals and Teachers

The fair dealing provision in Canada's copyright law permits teachers to copy and communicate short excerpts from copyright-protected works provided the dealing is "fair." The Fair Dealing Guidelines describe what is fair. These guidelines must be followed to prevent copyright infringement.

To help teachers better understand and comply with the copyright law, there are useful reference materials available online.

DO NOT COPY WORKBOOKS OR OTHER CONSUMABLES

Copying, scanning, or printing materials intended for one-time use is strictly prohibited.

"Materials intended for one-time use" are workbooks and exercise books in which a student records answers. These are materials created and intended for each student to have his or her own copy. Once a student completes the answers, these materials are of no use to another student.

Any copying from materials intended for one-time use exposes the person making the copy, the teacher, the school, and the school board to liability for copyright infringement.

This prohibition does not apply to reproducibles. A reproducible is not intended for one-time use, but is sold or provided with the rights holder's authorization to reproduce it for educational use.






